

Privacy Policy

This privacy statement is effective as of April 27, 2023. Please note that this privacy statement will be updated regularly to reflect any changes in the way we process your personal data or any changes in applicable laws.

This privacy policy describes how TGTH Sp. z o.o. ("we", "us", or "our") collects, uses, and shares personal information when you use our website <https://tgth.pl/> (the "Site").

1. Information We Collect

We collect the following types of personal information when you use our Site:

- **Personal Information You Provide:** We collect personal information that you voluntarily provide to us when you use our Site, such as your name, email address, and other contact information.
- **Automatically Collected Information:** We use cookies and other tracking technologies, such as Píksel Meta (Meta Platforms, Inc.) and Google Analytics (Alphabet Inc.), to automatically collect certain information when you use our Site, such as your IP address, browser type, operating system, and other usage information.

2. How We Use Your Information

We use the personal information we collect for the following purposes:

- To provide and improve our Site and services;
- To communicate with you about our products and services;
- To respond to your inquiries and requests;
- To analyze and improve the performance of our Site and services;
- To comply with legal obligations and enforce our policies;
- To prevent fraud and other prohibited or illegal activities.

3. How We Share Your Information

We may share your personal information with third parties in the following circumstances:

- With service providers and partners who help us operate our Site and provide our services;
- With our affiliates and subsidiaries for internal business purposes;
- With law enforcement or other government agencies to comply with legal obligations or to protect our rights and interests;
- In connection with a merger, acquisition, or other corporate transaction;
- With your consent or as otherwise required by law.

4. Cookies and Other Tracking Technologies

We use cookies and other tracking technologies, such as Píksel Meta and Google Analytics, to collect certain information about your use of our Site. You can control the use of cookies at the individual browser level, but if you choose to disable cookies, it may limit your use of certain features or functions of our Site.

5. Use of Calendly

We use Calendly to schedule appointments and meetings with our customers and clients. Calendly collects certain personal information from users who schedule appointments through our Calendly account, such as name, email address, and phone number.
